As in years past, every calendar year, all diocesan leaders must complete **at least 10 units** of professional development in the areas of professional standards and safeguarding. On the calendar below, you can see what the Diocese has to offer for the coming year. This year, there will be a range of modules available, and we ask you to read the module descriptions on pages 4–7 before enrolling to verify that the content of the module will be valuable to your ministry/work.

REGISTRATION IS NECESSARY

Only those who have registered for the modules will get an email ahead of time with the ZOOM link and modulespecific information, such as changes to the method of delivery or location of the session. The diocese provides the professional development opportunities in this program to assist you in meeting the professional development requirement associated with your role's leadership position. However, it should

be noted that there are several external professional development courses available that will also fulfill the mandate criteria. As a result, if you attend a module delivered by an external provider that addresses subjects related to safeguarding and professional standards, you may be eligible for credit points for your participation in the external course.

How to apply for recognition and credit for prior professional development

You will need to go to the website dow.sh/OPSS_LPDP and scroll down to Step 3 and then complete the "Diocesan Leadership Professional Development Program Registration" (Credit for Prior Learning). You only need to complete this online form if you are applying for recognition and credit for prior professional development, where you have attended external professional development and wish to be credited in place of attending the courses available in the Office of Professional Standards and Safeguarding calendar.

Please keep in mind that the module must have taken place during the same calendar year for which you are seeking credit, and evidence of attendance and completion will be required to process your application.

MODULE DETAILS & DESCRIPTIONS

Building Foundations

Date: Tuesday 28th, February 2023

Time: 10:00am – 5:00pm

Mode: F2F

Presenter: Michelle Scobie – Integroe Partners

Description: This module will provide an overview of the legislative obligations and diocesan requirements expected of those in ministry and those working with children, young people and adults at risk. Anyone in leadership who is new to the Diocese of Wollongong is required to complete this module. This module is also appropriate for anyone who would like a refresher on foundational child protection principles and associated diocesan policies.

Vicarious Trauma, Vicarious Resilience, and Sustaining ourselves in our Professional Roles

Date: Friday 17th, March 2023 **Time:** 10:30am – 2:00pm

Presenter: Carolyn Cousins – Tuned in Consulting

Description: Our ability to cope well with high levels of ongoing disruptive change is important in our various roles as we face each day with its different challenges, and this has certainly been true over the last year or more. There is a need to sustain good health and energy when under pressure, as well as learn to manage setbacks and adversities. This module seeks to explore the 'art of resilience' in ministry and the workplace and what neuroscience is teaching us about how our brains manage when we feel overwhelmed. This can help us safeguard ourselves so that we are better equipped in our ministries to serve our communities, be present for our family and friends, and take care of ourselves.

Supporting adult survivors of child sexual abuse

Date: Saturday 18th, March 2023

Description: The Diocese of Wollongong is committed to providing support to people who have been sexually abused. This support is extended to their family and other supporters. The Diocesan Office for Professional Standards and Safeguarding has engaged SAMSN to work closely with adult survivors, their families, and supporters to discuss their experiences and to share what might assist them in their healing. This day-long workshop will cover an understanding of the dynamics, impacts, and ripple effects of child sexual abuse while exploring the needs of supporters and survivors, and how SAMSN supports all parties impacted by child sexual abuse.

Exploring the Dynamics of Leadership

Date: Tuesday 28th, March 2023

Time: 11:00am – 2:30pm

Description: Breaking down the concept of what it means to be a 'leader' is an important step in safeguarding yourself and others. Effective leadership begins with understanding your role and the associated responsibilities. Within this module, participants will explore what it means to establish healthy boundaries within workplace/ministry relationships; the importance of accountability, and how we can promote transparent practices. This module aims to provide skills to empower leaders across the Diocese to face challenging dynamics while building a positive workplace.

Boundaries in physical and online environments

Date: Thursday 27th, April 2023

Time: 1:00pm – 4:30pm

Mode: ZOOM

Presenter: Nicki Sloss – E-Safety Commissioner

Description: This course outlines emerging online threats and how predatory behaviour occurs in the anonymity of the internet. It focuses on the most effective strategies for teaching children and adults at risk how to establish and maintain appropriate boundaries whether dealing with peers in person or online. You will leave the training knowing that you can make a difference by learning how to educate children and support their safe engagement with the internet and social media in their daily lives, and how, through education, we can teach children about the risks of online activity.

Creating a Child Safe Organisation

Date: Monday 1st, May 2023 **Time:** 10:00am – 1:30pm

Presenter: Trista - NAPCAN

Description: Presented by NAPCAN, 'Creating A Child Safe Organisation' will provide information on how, as an organisation, we can ensure that we are meeting all our legislative requirements to implement child-safe organisational practice. In addition to this we will focus on establishing a culture that supports and engages children and families; and how we can develop the right policies, procedures, and practices to keep children safe. These policies will include Codes of Conduct, effective recruitment practices and complaint management. Understanding and implementing these fundamental strategies will assist in achieving our overall goal of becoming a child-safe organisation.

Ethics and Moral Conduct

Description: History demonstrates that inadequate recruitment practices and a lack of onboarding, training, and assessment procedures can create risks for children. Topics covered in this session include how to discourage or screen people who are unfit to work with children; how to ensure that only the most qualified applicants with a positive attitude towards child safety are hired; the significance of the organisation's culture and expectations when employees work with children; and the level of commitment required when an organisation provides induction, training, and ongoing performance reviews supporting child safe standards.

Trauma Informed Practice

Description: Trauma Informed Practice is a concept that considers the significance of trauma in all aspects of our work. Trauma may be defined as the broad psychological and neurobiological effects of an event or series of events that produce feelings of overwhelming fear, stress, helplessness, or horror. By the end of this workshop, participants will have a better understanding of trauma-informed practice and how the focus shifts from "What's wrong with me?" to "What happened?" Trauma-informed practice is a different approach to engagement that recognises the person's life circumstances, both past and current, in order to deliver effective support, services, and practices with a healing orientation. Adopting trauma-informed practices creates the potential to enhance supportive involvement, health outcomes, and to enhance staff well-being working from a strengths-based framework. Trauma informed practice helps to facilitate empowerment and recovery and instils hope, optimism, and the understanding that recovery and post-traumatic growth are possible.

Mandatory Reporting and Reportable Conduct

Description: This workshop will explore in detail the NSW child protection legislative frameworks, specifically in relation to mandatory reporting and reportable conduct requirements. You will gain an understanding of the purpose and scope of these frameworks and your specific obligations as set out under the legislation. Ensuring the safety and wellbeing of children in your care, along with those in the wider community, begins with understanding your legislative responsibility to protect and report. This workshop will also explore the Child Safe Standards and the practical application of these standards in Diocesan agencies and ministries.

Lifecycle of the Employment Relationship

Description: Understanding the life cycle of employment relationships is important from a practical and safeguarding perspective. This module will explore the issues and challenges experienced by leaders from the stage of recruitment through to the potential termination of employment. Having a thorough understanding of these processes will assist in minimising the risks related to the management of employment relationships between volunteers and paid workers, while also providing effective strategies when faced with challenges.

Privacy and Confidentiality

Description: This training is intended to ensure that all employees are aware of privacy and confidentiality responsibilities and procedures, as well as the rationale behind their existence. This training will assist employees in comprehending how a failure to adhere to these requirements or an inability to maintain privacy and confidentiality across numerous platforms might endanger the most vulnerable members of our community. Important concepts such as records management, the length of time records should be maintained, when and why data can be shared, and privacy and confidentiality regulations will also be discussed throughout the training session.

Understanding the role of Emotional Intelligence – managing yourself and others

Description: Emotional intelligence (EI) is one's ability to perceive, use, understand, manage, and handle emotions; something that is critical in all areas of ministry. This module will provide you with an overview of the key findings of EI from neuroscience, whilst examining the process of developing EI and how we can increase it. You will also consider EI in the context of leadership styles and their role in managing communication and difficult conversations/behaviours.

Child focused safety practices across environments

Date: Wednesday 23rd, August 2023

Description: This training course will discuss how to manage risks in both offline and online settings to prevent abuse and increase the likelihood of preventing abuse, particularly if your organisation lacks natural lines of sight from other adults or has behavioural expectations when interacting with children.

Responding to child disclosures – positive practices

Date: Friday 13th, October 2023 **Time:** 10:00am – 1:30pm

Description: By describing in detail how to react to a disclosure, help a child or family in danger, and see early signs or risk factors, the course will help support you in understanding and implementing your legal obligation to report abuse. This workshop will give you the tools to ensure the safety of children, including how responses to disclosures of abuse can have a profound impact on their ability to feel safe and recover from the trauma of abuse.

Managing challenging behaviours while building a positive workspace

Date: Thursday 26th, October 2023

Presenter: Deb Walker – Trinity Psychology

Description: This course will guide you in dealing with challenging employee behaviour and how to foster a positive workplace. In order to build a healthy work environment, the course will address techniques for resolving disagreements and promoting a productive office atmosphere. This course also demonstrates to you how to enable children to self-regulate their own behaviour, set behavioural standards, and provide a framework for social-emotional learning.

Engaging positively with children when raising concerns

Description: A child-focused complaint system aims to make it easier for children who are at risk of abuse or neglect to speak up. This course will discuss how, when children are in danger, it is the obligation of the organisation to act immediately to protect them. It will describe how to communicate with a child if there are concerns, how to resolve those issues swiftly, thoroughly, and fairly, and how to ensure that all reporting requirements have been addressed. A child-safe organisation creates child-centred complaint processes and provides staff with the information and skills they need to respond to complaints effectively.

Anyone in leadership who is new to the Diocese of Wollongong is required to complete this module. The National Association for Prevention of Child abuse and Neglect (NAPCAN) was co-founded by Rosemary Sinclair AO and Christine Stewart OAM in 1987, because they saw that the abuse and neglect of children was a taboo topic in Australian society in the 1980s. NAPCAN's strategy is to support and encourage changes in individual and community behaviour to stop child abuse and neglect before it starts by: promoting quality child abuse prevention research, advocating for child safe policies and strategies, demonstrating good practice, Supporting the safety and wellbeing of children and young people and Coordinating National Child Protection Week and promoting the Play Your Part strategy.

Carolyn Cousins is a clinical social worker and educator who has worked in the violence, abuse, and trauma fields for over 25 years, both in Australia and the UK. She also consults with a range of churches around domestic and family violence.
